**NARRATIVE**

ON 01/23/2011 AT APPROXIMATELY 0709 HOURS [REDACTED] CALLED THE DUNN POLICE DEPARTMENT AND REPORTED THAT BRANDON JOLVON BETHEA B/M 23 Y.O.A ROBBED [REDACTED] AT GUN POINT IN THE KITCHEN OF 506 E. VANCE ST. [REDACTED] STATED THAT [REDACTED] WAS IN THE KITCHEN OF 506 E. VANCE ST. WITH MR. BETHEA. [REDACTED] THEN STATED THAT [REDACTED] AND MR. BETHEA WERE SMOKING MARIJUANA IN THE KITCHEN. [REDACTED] STATED MR. BETHEA THEN FORCED [REDACTED] TO HAVE SEX WITH HIM IN THE KITCHEN. [REDACTED] STATED A FEW MINUTES AFTER THEY HAD SEX MR. BETHEA THEN PULLED A GUN ON [REDACTED] AND ORDERED [REDACTED] TO TAKE OFF HIS PANTS AND GIVE HIM ALL OF [REDACTED] MONEY. [REDACTED] STATED MR. BETHEA ALSO TOOK HIS CELL PHONE AND SUNGLASSES. [REDACTED] DESCRIBE THE FIREARM AS A SILVER AND BLACK SMALL HANDGUN. I OFFICER J.A. BUTLER, LT. CHAVIS, AND OFFICER PARRILLA THEN ORDERED MR. BETHEA TO COME OUT OF THE HOUSE THROUGH THE BACK DOOR WHICH LEADS INTO THE KITCHEN. AFTER A FEW MINUTES MR. BETHEA THEN WALKED OUT OF BACK DOOR, WE THEN PLACED MR. BETHEA IN HANDCUFFS AND WALKED INTO THE RESIDENCE TO ATTEMPT TO LOCATE THE FIREARM. WHILE MYSELF AND OTHER OFFICERS WERE LOOKING FOR THE FIREARM MR. BETHEA SAT IN A CHAIR IN THE KITCHEN. A USED CONDOM WAS FOUND ON THE KITCHEN FLOOR WHERE [REDACTED] STATED THEY HAD SEX. WHILE WE WERE STILL LOOKING FOR THE FIREARM MR. BETHEA ASKED ONE OF THE FEMALES IN THE LIVING ROOM OF THE RESIDENCE TO GET HIS JACKET OUT OF ONE OF THE BEDROOMS. OFFICER PARRILLA WALKED WITH THE FEMALE SUBJECT TO RETRIEVE MR. BETHEA'S JACKET. THE FEMALE WENT TO THE CLOSET IN THE BACK LEFT BEDROOM OF THE HOME, SHE THEN POINTED OUT MR. BETHEA'S JACKET AND OFFICER PARRILLA RETRIEVED THE JACKET AND BROUGHT IT TO THE KITCHEN. [REDACTED] STAYED OUTSIDE OF THE RESIDENCE STANDING IN THE BACKYARD BESIDE MY PATROL VEHICLE. AS WE WERE INSIDE THE RESIDENCE ATTEMPTING TO LOCATE THE FIREARM [REDACTED]

Narrative  
 APPROACHED THE BACK DOOR OF THE RESIDENCE AND STATED HE FOUND THE FIREARM. [REDACTED] STATED THE FIREARM WAS UNDER THE HOUSE RIGHT BEHIND THE SMALL DOOR THAT LEADS UNDER THE HOUSE. MYSELF AND OFFICER PARRILLA THEN WENT OUTSIDE TO THE DOOR THAT LEADS UNDER THE HOUSE OPENED IT AND RECOVERED THE FIREARM. THE FIREARM WAS A BLACK AND SILVER BERSA .380 WITH THREE ROUNDS IN THE MAGAZINE. WHEN MYSELF AND OTHER OFFICERS WERE ATTEMPTING TO LOCATE THE FIREARM LT. CHAVIS AND OFFICER PARRILLA LOCATED A HOLE IN THE FLOOR OF ONE OF THE KITCHEN CABINETS WHICH LED DIRECTLY TO THE CRAWL SPACE OF THE RESIDENCE WHERE WE LOCATED THE FIREARM. THERE WERE NINE OTHER PEOPLE IN THE RESIDENCE WHEN THIS INCIDENT OCCURRED INCLUDING CHILDREN. [REDACTED] THEN WALKED TO THE DUNN POLICE DEPARTMENT WHERE HE WAS INSTRUCTED TO WAIT FOR US. LT. CHAVIS THEN CALLED IN DET. TYNDALL. WHEN DET. TYNDALL ARRIVED WE WENT BACK INTO THE RESIDENCE AND BRIEFLY TALKED WITH ALL OF THE OCCUPANTS OF THE HOME. I THEN TRANSPORTED MR. BETHEA TO THE DUNN POLICE DEPARTMENT, I ALSO TRANSPORTED MR. BETHEA'S JACKET WITH HIM. WHEN WE ARRIVED AT THE POLICE DEPARTMENT OFFICER PARRILLA SEARCHED MR. BETHEA'S JACKET. OFFICER PARRILLA FOUND A PAIR OF BLACK EASTON GLOVES AND A FLASHLIGHT IN THE LEFT SIDE FRONT POCKET. HE THEN FOUND A PAIR OF SUNGLASSES, A SPRINT BLACKBERRY CURVE CELL PHONE, AND A BULLET IN THE RIGHT SIDE FRONT POCKET. OFFICER PARRILLA THEN FOUND TWO SMALL PACKAGES CONTAINING AN OFF WHITE ROCK LIKE SUBSTANCE IN THE LEFT SIDE ZIPPER POCKET. ONE PACKAGE WAS 1.7 GRAMS AND THE OTHER WAS 5.2 GRAMS. MYSELF AND OFFICER PARRILLA THEN TESTED THE CONTENTS OF BOTH PACKAGES WITH A COCAINE IDENTIFICATION SWIPE. THE 1.7 GRAM PACKAGE TESTED POSITIVE BUT THE 5.2 GRAM PACKAGE DID NOT TEST POSITIVE. MR. BETHEA AND ALL OF THE ITEMS THAT WERE RECOVERED WERE THEN TURNED OVER TO DET. TYNDALL.

\*\*\*SUPPLEMENT\*\*\*

ON 01/23/2011 I INV, TYNDALL INTERVIEWED [REDACTED] AND THE SUSPECT BRANDON BETHEA. STATEMENTS WERE COLLECTED FORM BOTH INDIVIDUALS. THE VICTIM WAS SENT TO BETSY JOHNSON HOSPITAL TO HAVE A SEXUAL ASSAULT KIT PERFORMED AND LATER TRANSPORTED HOME. THE SUSPECT, BRANDON BETHEA CONFESSED TO THE CRIMES LISTED ABOVE AND WAS TRANSPORTED TO HARNETT COUNTY L.E.C. BY CAPTAIN T. STRICKLAND AND I. BRANDON BETHEA WAS PLACED UNDER A \$150,000 SECURED BOND AND WILL HAVE A FIRST APPEARANCE ON 01/24/2011 IN LILLINGTON, N.C. THIS CASE WAS CLOSED, AND CLEARED BY AN ARREST.
